All the statements in this report are based on the financial information produced by the Companies, according to Romanian Accounting Regulations and by discussions with the management, namely Mr. Teofil Dascălu. No attempt has been made to independently verify those statements and they are taken as they have been mentioned to bv the US management.

The figures included in this report are based on the aggregations of the two companies financials. No steps have been taken to apply consolidation procedures, and, as such, no inter-company transactions or balances have been cancelled or eliminated.



# Summary

The shareholders of the Company are (in the order from the Statute): Mr. Dascălu Teofil - 16.25%, J. Houtsma Beheer B.V - 16.25%, Lettinga Landbow B.V - 22.5%, Fermasol B.V - 22.5% and TDS Finance B.V.- 22.5%.

The Farms operate the land leased from both individuals and legal entities. On December 31, 2017 both companies were operating 2,117 ha land (see other operating income for the structure).

During 2017 the Company received government and EU grants for agriculture, namely for the cultivated surfaces and for the fuel. Details are to be found in the Cost Structure section of the report.

The sales increased by 11%, due to the 70 ha area extension, mix of products. The production volumes stayed relatively stable.



# Our Executive Summary

During 2017, 400 ha of crops were damaged by the weather. The production value was recovered from the insurance company (which contributed to the profit increase of 57% Y to Y).

Due to unusual unfavorable weather conditions, namely the heavy snow in April 2017, a large area cultivated with corn and sunflower had to be re-seeded. Thus, 98.62 ha of maize were re-seeded, for which 137 sacks of seeds and 550 liters of diesel were consumed, that worth an additionally 12,800 EUR. Also services from Frizonmaica were required to re-seed an area of 88.81 ha using the Versatile tractor and the Gaspardo Maximetro seeder, resulting a supplementary cost of 2,700 EUR. Regarding the sunflower crop, an area of 77.78 ha had to be re-seeded, for which 32 sacks of seeds and 560 liters of diesel were consumed, worth 7,200 EUR. In this case too, there was a need for services from Frizonmaica for re-seeding an area of 61.8 ha with the Versatile tractor and the Gaspardo Maximetro seeder. As result of this event, an additional 20,000 EUR was spent for the extra consumption, and for the provided services the sum of 6,800 EUR, which led to an increase in the cost of maize and sunflower crops and implicitly a decrease in profitability.



#### **STATEMENT OF FINANCIAL POSITION**

The Companies have negative equity which is less than 1/2 share capital. According to the Romanian regulations, the associates should take action in order to re-establish the ratio between equity and share capital.

The group continued investing in new equipment and in modernising the existing equipment, hence the increase of 19% in the value of fixed assets.

The main finance line for the new equipment is the finance lease. Leasing liabilities increased as a consequence. The lease agreements are for the maximum of 5-7 years.

Working capital is negative, the resources to cover it being covered by the associates and suppliers' credit.

Payables remain stable. A reclassification separating trade payables from shareholders' loans has been operated in 2017 statements. The correspondent figure for 2016 is approx. 1.7 million EUR.

Receivables increase comes mainly from the intercompany financing by Frizonagra of Agricola Oostroem through trade sales.

Incomes from services comes from providing various services to the third parties, like fertilizing, subsoiling, cultivating, seeding, chemical treatments, harvesting, weighing, cereals analysis etc. Sales of services value increased in 2017 compared to 2016, by 543%, as a result of the acquisition and modernisation of new assets and equipment. Significant part of the service revenue comes from servicing other group companies.

Raw materials and consumables decreased by 8% as a result of a better management as a group, creating synergies and a higher bargaining power with suppliers. In the same context, emphasis was put on using active substances with greater efficiency vs. commercial products for crops.

Salaries remained stable as the team was not significantly changed.

At the end of 2017, the monthly depreciation of acquisitions during the year is 7,700 EUR, and the one related to acquisitions since the company's establishment is 21,400 EUR. Much of the 2017 depreciation refers to the investments in spare parts purchased for machinery repairs. The equipment acquisition value of 2017 is 729,350 EUR and the associated depreciation period is the maximum allowed by law for each acquisition category. 

Regarding the seeds, pesticides, fuel changes were noted, in the sense of increased expenses due to the increase of the production area.

The commercial discounts received for seeds, pesticides and fertilizers from the main suppliers, namely Alcedo and Agricover, increased by 146 EUR'000, taking into account the larger ordered quantities, necessary for the efficient performance of the specific activities.

During the year 2016, the APIA subsidies for diesel and for the exploited areas were received. The amounts came from various types of specific subsidies, detailed in the table on the left, which are recorded in the accounting when they are approved according to the APIA statement, not when they are actually received in the bank account.

Salary costs remains stable, as the team remain basically the same.

The group has still a reserve of 300 ha of land, that can be subject for subsidy, as soon as it meets the necessary requirements.
